CPT Code Changes Additional Q&A

Many providers have questions about the CPT® Code Changes effective January 1st, 2013. Here's a list of additional Q&A, but first, [a brief overview](#):

The codes used for billing common psychotherapy services are changing, and the old codes will no longer be used as of January 1st, 2013. These changes are mandated on a federal level by HIPAA and can affect billing systems, contracts with payers and documentation requirements. Further research is required by each practice before the January 1st change date to make sure that you code to your payers' specifications, both public and private.

How do these changes affect you as a mental & behavioral health care provider? The most commonly used codes for psychotherapy are affected, especially the 908 codes. The AMA 2013 CPT® code book ([continued](#) ...)
